Upon motion made by Bro. Kenneth Miller and seconded by Bro. Joseph Sbath, Bros. Joe Morris and Alphonse Rigod were unanimously elected to serve on the Finance Committe as provided by the By-Laws.

The Report of the Investigation Committe being favourable, ballots were cast for Affiliation of Sinim Lodge of Bro. Mathado Uyeda, Master Mason of good standing in Tokyo Lodge #125, Philippine Constitution. All being clear in the South, West and East, Bro. Uyeda was unanimously elected to become an Affiliated Member of Sinim Lodge. Bro. Uyeda was then admitted into the Lodge and informed of the result, and the by-law was signed.

A motion was made by Bro. Joseph N. Sbath and seconded by Bro. Kenneth C. Miller and unanimously accepted by the brethren that the insufficient amount of the expense for the Installation Party after deducting the receipts of \(\frac{1}{2}\)1,500 per head for the members and their guests, the balance will be borne by the Lodge.

The Master-Elect, Bro. J. Sbath called up the Brethren to salute the outgoing Wor. Master Anselm Chuh with the Public Honor of Three Times Three, in appreciation of his guidance of the Lodge during the past year.

At 4 P.m. by order of the Wor. Master, the Lodge was called from Labour to Refreshment.

At 6.30 P.M. the Lodge was called from Refreshment to Labour again before the door was open to admit Ladies and friends for the Public Installation Ceremony.



Minutes of the Monthly Stated Meeting of Sinim Lodge A.F. & A.M. held at the Tokyo Masonic Temple on October 19th, 1954.

The Lodge was opened on the Master Mason Degree in due form at 6.30 P.M. with Wor. Bro. Joseph Sbath in the East, Bro. Kenneth C. Miller in the West, and Bro. Hawklin Chuh in the South. Members and visitors numbering twenty-two in all were present as per Tyler's register.

The Circular convening the meeting was read.

The Minutes of the Annual Meeting held on September 21, 1954 were read and unanimously approved. A letter from Wor. Bro. Peter H. Chao, Past Master of Sinim Lodge was read to the Lodge.

Bro. Kenneth C. Miller as Chairman of the Finance Committee, reported to the Lodge that the Committee recommends the following:

- (1) That a petty cahs fund in the amount of \$20,600 be set up for the purpose of paying such expenses as postage, stationeries, printing and other supplies, and this petty cash fund be entrauted to Bro. Hawklin Chuh for disbursement for the abore said purposes without approval of the Lodge, and that this fund is to be replenished from time to time as it may become necessary. Upon motion made, and seconded this was unanimously approved the Lodge.
- (2) That in approving payment or signing checks two signatures will always be required in accordance with the by-laws and that the signatures of the Treasurer, plus that of the Worshipful Master or in the absence of the Worshipful Master, the Chairman of the Fignance Committee be authorized to sign for the Lodge. Upon motion made, and seconded this was unanimously carried.
- (3) The committee recommends that no bonds be required of the Treasurer, Norman, H. Ball, during his term of office. Upon motion made and seconded, this was unanimously carried.
